At Keilor Downs College (KDC) we seek to provide resources and facilities that enhance your child's ability to learn and reach their goals. The annual Parent Payment arrangements are an extremely important contributor to being able to continually maintain and improve our curriculum delivery and school facilities.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and opportunities for our students. In this communication, we would like to advise you of the college's voluntary financial contributions for 2023.

Your contributions will:

- Enhance the classroom experience through the provision of equipment and materials
- Enhance student engagement in learning through curriculum-related guest speakers / incursions / excursions / workshops

### **Educational items for students to own**

### **Financial Support for Families**

Keilor Downs College understands that some families may experience financial difficulty and offers a range of support options, including:

- Camps, Sports and Excursions Fund (CSEF) – Parents or students who hold a valid concession card (Health Care Card or Pensioner Concession Card) or are a temporary foster parent, may be eligible. The CSEF amount per student is \$225 per year. This can be allocated towards any camps, sports, excursions or incursions. Please contact the General Office for further information.
- Second-hand books / uniform – the college subscribes to Sustainable School Shop, an online platform where parents can buy and sell second-hand textbooks and uniform. Please see information on the college website.
- State Schools Relief (SSR) – this organization provides limited assistance to families who are Health Care Card holders. Request to State Schools' Relief can only be lodged by the school.
- Payment plans for Extra-Curricular Items and Activities are available – please speak to the General Office staff to arrange.
- Student Wellbeing Coordinators – Ms Arif (for students in Years 7-9) and Ms Sobh (for students in Years 10-12) have authority to make arrangements within the college, and to refer families to external organisations which may be able to provide support where families are in need. Please make phone contact via the General Office initially; an appointment time can then be organised if necessary.

# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW

### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
